

INFORMATION TO BE COLLECTED

By using Alibi – call with background (further AlibiCall), you are also agreeing to our Terms of Use. Please make sure you read and agree with our Terms of Use if you want to use AlibiCall.

By using AlibiCall, you allow us to collect, use, disclose, and retain your personal information. You can be sure that we will only use your information as described in this Policy.

When you use AlibiCall you voluntarily give us personal information (phone number). This information will be collected and stored on our servers in order for us to allow you access to AlibiCall. When you install the AlibiCall, you'll also be asked to allow us access to your mobile device's address book. We do not collect and store the copy of the phone numbers and names of all your contacts.

AlibiCall allows you to call any US number. We will keep your call logs for billing and legal records. When calling through AlibiCall, just like regular phone calls you make, details of the call are available to the phone operator of the person you called.

USES AND RETENTION

We use your information for the following purposes:

1. Make our service available. We use your Registration information to register you in the AlibiCall; process your payments; display the name of the contact as it appears in your address book when a call is received on the AlibiCall. We keep your personal information for as long as you use AlibiCall so we can provide you all functions of the AlibiCall.
2. Improve. We use call log information and usage information to detect potential outages and technical issues to improve AlibiCall.

Data Retention: Unless otherwise specified, we retain information as long as it is necessary and relevant for us to achieve the purposes referred to above or to enable us to comply with our legal data protection retention obligations. Upon deactivation of your account, we will keep the personal data which we are required to keep to comply with laws, or other legal reasons.

DISCLOSURE

Your data is kept safe with us, but we do share your personal information with third parties we trust in order to provide you with our services, as follows:

1. App Providers and Other Third-Parties: We may disclose your information to service providers and other third-parties under contract who help with providing you and others AlibiCall on our behalf or other services provided by third-parties via AlibiCall. They are required to secure the data they receive.
2. Legal and Law Enforcement: We may disclose your information to law enforcement, governmental agencies, or authorized third-parties, in response to a verified request relating to terror acts, criminal investigations or alleged illegal activity or any other activity that may expose us, you, or any other AlibiCall user to legal liability.
3. Change of Control – New Owners: We may share your information with another business entity, if we plan to merge with or be acquired by that business, or are involved in a transaction with similar financial effect. In such a situation we would make reasonable efforts to request that the new combined entity or other structure follow this Policy with respect to your personal information. If your personal information was intended to be used differently, we would ask the new entity to provide you with prior notice.

SECURITY

We maintain technical, physical, and administrative security measures to protect the security of your personal information against loss, misuse, unauthorized access, disclosure, or alteration. We use

firewalls, physical access controls to data centers we use and information access authorization controls. We need your help too: it is your responsibility to make sure that your personal information is accurate and that your account registration information are secure and not shared with third-parties.
